Frank Childs (former resident of Calif.) then commander of the East End VFW Post met with some veterans of California to discuss the possibility of forming a veteran organization in California. At the start there was considerable controversy over whether to form a VFW Post or a American Legion Post. It was finally decided to have a Legion Post because it would give more veterans a chance to belong to the organization. So on March 3, 1953 the first meeting was held and



## 2012 NSP/NBD Projects

The city has increased our nsp and nbd funds this year for the first time in a long time! Over the past 6 or 7 years the funds have dwindled from \$10,000 each to \$2,000 last year. the Charter was closed. Also at this meeting elections were held and the first officers were elected, they were Commander Gene Bradford, 1st Vice Edward Hehn, Adjutant Harold Holt, Finance Officer Donald Hehn, Sgt. of Arms, Jack Hilge, Chaplain George Dragoo. Then the dark clouds of disbelief hung over our young American Legion Post, because of the stigma attached to the fact that previous to this time other organizations had tried to organize in California, but failed within two years. So many said openly that we could not survive more than two years as a Legion Post. However, we had our hearts set and we were determined to be successful. The first meetings were held at the D of A Hall (which later became theirs). It was voted by the membership that we held 2 meetings a month on the 1st and 3rd Mondays.

At the June meeting two names were suggested by the membership for the post be named in honor of. The first man from the area who lost his life in World War II was the first to be suggested, but when his mother was asked if we could honor her son in this manner she asked that the post not be named after her son because she thought that in passing the post she would be reminded of how her son lost his life. Therefore the second name to be suggested was Stanley (Pete) Clift the second man from the area to lose his life in defense of his country in W.W. II. Stanley Clift's name was then chosen to receive this honor.

In June 1953 the post colors were purchased. August 1953 the post bowling team was formed. Sept. 1953 the membership voted to hold meetings the 1st and 3rd Fridays. Our permanent charter was received in January 1954. On March 19, 1954 the post held a celebration to mark the birthday of the American Legion, at this celebration the 4th Dist. Commander Ruddy Gruber presented us with the charter. January 1955 Allen White (resident) was appointed to organize a disaster team. Feb. 1955 John Yowell read the proposed By-Laws of the post and they were voted on and adopted by the membership. Also in Feb. 1955 the Post was incorporated. March 1955 it was decided by the membership to find another place to meet and move from the D of A Hall. April 1955 Commander Ed. Hehn was presented a trophy for obtaining quota. This trophy was a gavel bell, inscribed Stanley Clift Post 563. June 1955 a ball team was formed, which was to be composed of paid up members who wished to play on the team. Sept 1955 it was decided to go along with the suggestion to form a club outside the Legion called the Legionnaires Friends Club. This club would be made up of men who were not eligible to belong to the Legion who desired to help the Legion, and that they would not be a part of the regular Legion, but would have the opportunity to associate with us and meet in our hall. December 1955 we discussed the possibility of buying property to be used as a legion post. Jan.1956 two pieces of property were suggested but were turned down by the membership. March 1956 we looked at a camp on the Ohio River bank, but this was turned down by the membership. April 1956 we de-

cided to buy the D of A Hall at 5777 Kellogg Ave. May 1956 the Mt. Washington Bldg. and Loan Assoc. was asked to finance the mortgage. Oct. 1956 Harry Leist was appointed chairman of a delegation to close the deal on the hall. This group consisted of Harry Leist, Ralph Frazier, Eudell Jones, John Hemer, and Neil Kaylor. So the hall was purchased from the D of A and financed by the Mt. Washington Bldg. and Loan Association. November 1956 the lot adjacent to the hall on the west side was purchased from the California Methodist Church for \$250.00. Sept. 1957 repairs and remodeling of the hall was started by the members.
